## A BILL FOR

1 An Act to legalize and validate the proceedings of the Board  
 2 of Supervisors of Dallas County, Iowa, authorizing and pro-  
 3 viding for the issuance of County Home Bonds of said County  
 4 and for the levy of taxes for the payment of said bonds and  
 5 declaring the bonds issued pursuant to said proceedings to  
 6 be enforceable obligations of said County.

7 WHEREAS, it appears from the records of the Board of Super-  
 8 visors of Dallas County, Iowa, that said Board of Supervisors  
 9 ordered that at the regular election to be held in said County  
 10 on November 5, 1968, there be submitted to the voters of said  
 11 County the proposition of levying an annual tax not to exceed  
 12 one-half mill for a period of five years on all taxable prop-  
 13 erty in Dallas County for the purpose of constructing a two  
 14 story addition to the Dallas County Home to be used for a din-  
 15 ing room and dormitory quarters, and said proposition was duly  
 16 submitted to the voters of said County at said regular elec-  
 17 tion on November 5, 1968; and

18 WHEREAS, after canvassing the results of the election on  
 19 the aforesaid proposition it was found and determined that  
 20 said proposition was approved by more than sixty per cent  
 21 (60%) of the total number of votes cast for and against said  
 22 proposition at said election; and

23 WHEREAS, in reliance upon the favorable vote cast at said  
 24 election the Board of Supervisors of said County has by reso-  
 25 lution authorized and provided for the issuance of \$150,000

1 County Home Bonds for the purpose aforesaid and has made pro-  
 2 vision for the levy of taxes sufficient to pay said bonds and  
 3 the interest thereon not in excess of one-half mill per annum  
 4 for a period of five years; and

5 WHEREAS, doubts have arisen concerning the validity and  
 6 legal sufficiency of said election and proceedings and provi-  
 7 sions made for the issuance and payment of said bonds and it  
 8 is deemed advisable to put such doubts and all others that  
 9 might arise concerning the same forever at rest; NOW THEREFORE,

10 *Be It Enacted by the General Assembly of the State of Iowa:*

11 Section 1. That all proceedings heretofore taken by the  
 12 Board of Supervisors of Dallas County, Iowa, preliminary to  
 13 and in connection with the election held in said County on  
 14 November 5, 1968, and all proceedings heretofore taken by the  
 15 Board of Supervisors of Dallas County, Iowa, preliminary to  
 16 and in providing for the issuance of County Home Bonds of said  
 17 County to the amount of One Hundred Fifty Thousand Dollars  
 18 (\$150,000), and for the levy of taxes sufficient to pay said  
 19 bonds and interest thereon pursuant to said election, are  
 20 hereby legalized, validated and confirmed, and said County  
 21 Home Bonds issued, sold and delivered pursuant to and in  
 22 accordance with said proceedings are hereby declared to be  
 23 legal and to constitute valid and binding obligations of said  
 24 County.

25 Sec. 2. This Act, being deemed of immediate importance,  
 26 shall take effect and be in force from and after its publica-  
 27 tion in the Perry Daily Chief, a newspaper published in Perry,  
 28 Iowa, and in The Dallas County News, a newspaper published in  
 29 Adel, Iowa.

EXPLANATION

This bill legalizes proceedings whereby the Dallas County Board of Supervisors authorized an election for the purpose of voting upon the issuance of bonds to finance certain improvements to the county home, and an election was held and more than sixty percent of the votes cast were favorable.
