A BILL FOR

- 1 An Act relating to legalizing acts of notaries public and
- 2 acknowledgments.
- 3 *Be It Enacted by the General Assembly of the State of Iowa:*
- 4 Section 1. Section five hundred eighty-six point one
- 5 (586.1), Code 1966, is hereby amended as follows:
- 6 1. By striking from subsection one (1), line one (1),
- 7 the figures "1950" and inserting in lieu thereof the figures
- 8 "1960".
- 9 2. By striking from subsection two (2), line one (1), the
- 10 figures "1950" and inserting in lieu thereof the figures
- 11 "1960".
- 12 3. By striking from subsection three (3), line five (5),
- 13 the figures "1958" and inserting in lieu thereof the figures
- 14 "1966".
- 15 4. By striking from subsection four (4), line three (3),
- 16 the figures "1950" and inserting in lieu thereof the figures
- 17 "1960".
- 18 5. By striking from subsection six (6), line two (2), the
- 19 figures "1950" and inserting in lieu thereof the figures
- 20 "1960".
- 21 6. By striking from subsection seven (7), line two (2),
- 22 the figures "1950" and inserting in lieu thereof the figures
- 23 "1960".
- 24 7. By striking from subsection seven (7), lines three (3)
- 25 and four (4), the words and figures "[Codes 1924 to 1939;

1 section 558.28] to and including the Code of 1958," and in-
2 serting in lieu thereof the words and figures "Codes 1924
3 to 1939 and section 558.28, Code 1946 to and including the
4 Code of 1966,".

5 8. By striking from subsection seven (7), lines seven
6 (7) and eight (8), the words and figures "[Code 1924 to
7 1939; section 558.29] to and including the Code of 1958," and
8 inserting in lieu thereof the words and figures "Codes of
9 1924 to 1939 and section 558.29, Code 1946 to and including
10 the Code of 1966,".

11 9. By striking from subsection eight (8), line two (2),
12 the figures "1950" and inserting in lieu thereof the figures
13 "1960".

14 10. By striking from subsection nine (9), line two (2), the
15 figures "1950" and inserting in lieu thereof the figures "1960".

16 Sec. 2. This Act shall not affect pending litigation nor
17 shall it operate to revive the rights or claims previously
18 barred nor permit an action to be brought or maintained upon
19 any claim or cause of action which is barred by any statute
20 which is in force prior to July 1, 1970, nor shall it affect
21 any action which may be brought on or before January 1, 1971.

EXPLANATION

This bill extends the dates of previous legalizing acts relating to notaries public and acknowledgments.
