## A BILL FOR

1 An Act relating to special limitations of actions regarding the  
2 recovery of interests in real estate.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Section six hundred fourteen point fourteen  
5 (614.14), Code 1966, is hereby amended as follows:

6 1. By striking from line eight (8) the figures "1950" and  
7 inserting in lieu thereof the figures "1960".

8 2. By striking from line eighteen (18) the figures "1962"  
9 and inserting in lieu thereof the figures "1971".

10 Sec. 2. Section six hundred fourteen point fifteen (614.15),  
11 Code 1966, is hereby amended as follows:

12 1. By striking from line three (3) the figures "1950" and  
13 inserting in lieu thereof the figures "1960".

14 2. By striking from lines ten (10) and eleven (11) the word  
15 and figures "July 4, 1961" and inserting in lieu thereof the  
16 word and figures "July 1, 1970".

17 3. By striking from line twenty (20) the word and figures  
18 "July 4, 1961" and inserting in lieu thereof the word and  
19 figures "July 1, 1970".

20 Sec. 3. Section six hundred fourteen point sixteen (614.16),  
21 Code 1966, is hereby amended by striking from line seven (7) the  
22 word and figures "July 4, 1961" and inserting in lieu thereof  
23 the word and figures "July 1, 1970".

24 Sec. 4. Section six hundred fourteen point seventeen  
25 (614.17), Code 1966, is hereby amended as follows:

1 1. By striking from line two (2) the figures "1950" and  
2 inserting in lieu thereof the figures "1960".

3 2. By striking from line eleven (11) the figures "1950" and  
4 inserting in lieu thereof the figures "1960".

5 3. By striking from line sixteen (16) the word and figures  
6 "July 4, 1961" and inserting in lieu thereof the word and fig-  
7 ures "July 1, 1970".

8 4. By striking from line forty-six (46) the word and fig-  
9 ures "July 4, 1961" and inserting in lieu thereof the word and  
10 figures "July 1, 1970".

11 Sec. 5. Section six hundred fourteen point twenty (614.20),  
12 Code 1966, is hereby amended by striking from line nineteen (19)  
13 the word and figures "July 4, 1961" and inserting in lieu  
14 thereof the words and figures "July 1, 1970".

15 Sec. 6. Section six hundred fourteen point twenty-two  
16 (614.22), Code 1966, is hereby amended as follows:

17 1. By striking from line ten (10) the figures "1950" and  
18 inserting in lieu thereof the figures "1960".

19 2. By striking from line twelve (12) the figures "1963" and  
20 inserting in lieu thereof the figures "1971".

21 3. By striking from line fifteen (15) the figures "1963" and  
22 inserting in lieu thereof the figures "1971".

23 4. By striking from line twenty-five (25) the word and fig-  
24 ures "July 4, 1961" and inserting in lieu thereof the word and  
25 figures "July 1, 1970".

26 Sec. 7. Nothing in this Act shall be construed to revive any  
27 cause of action previously barred by the provisions of sections  
28 herein amended.

#### EXPLANATION

This bill extends the dates of previous legalizing acts in chapter 614 of the Code which relates to limitations of actions.
