## A BILL FOR

1 An Act relating to a department of soil conservation.

2 *Be It Enacted by the General Assembly of the State of Iowa:*

3 Section 1. Section four hundred sixty-seven A point three  
4 (467A.3), Code 1966, is hereby amended as follows:

5 1. By striking subsection three (3) and inserting in lieu  
6 thereof the following new subsection:

7 "3. 'Department' or 'department of soil conservation' means  
8 the agency created by section four hundred sixty-seven A point  
9 four (467A.4) of the Code."

10 2. By adding the following new subsection:

11 " 'Committee' or 'state soil conservation committee' means  
12 the committee established by section four hundred sixty-seven  
13 A point four (467A.4) of the Code."

14 Sec. 2. Section four hundred sixty-seven A point four  
15 (467A.4), Code 1966, is hereby amended as follows:

16 1. By striking from subsection one (1), lines six (6) and  
17 seven (7), the words "state soil conservation committee. The  
18 committee" and inserting in lieu thereof the words "department  
19 of soil conservation. The department shall be administered in  
20 accordance with the policies of the state soil conservation  
21 committee, which".

22 2. By inserting in subsection two (2), line six (6), after  
23 the word "committee" the words "or department".

24 3. By striking from subsection two (2), line eight (8),  
25 the words "it may require. It" and inserting in lieu thereof

1 the words "as either may require. The committee".

2 4. By striking from subsection two (2), line fourteen (14),  
3 the words "its functions" and inserting in lieu thereof the  
4 words "the functions assigned the committee or the department  
5 by law".

6 5. By striking from subsection two (2), line twenty (20),  
7 the word "committee" and inserting in lieu thereof the word  
8 "department".

9 6. By striking from subsection four (4), lines two (2)  
10 and three (3), the words "state soil conservation committee"  
11 and inserting in lieu thereof the words "department of soil  
12 conservation".

13 Sec. 3. Section four hundred sixty-seven A point five  
14 (467A.5), Code 1966, as amended by chapter two hundred sixty-  
15 three (263), section one (1), Acts of the Sixty-third General  
16 Assembly, First Session, is hereby further amended as follows:

17 1. By striking from subsection three (3), line eleven (11),  
18 the word "committee" and inserting in lieu thereof the word  
19 "department".

20 2. By striking from subsection four (4), line one (1), the  
21 word "committee" and inserting in lieu thereof the word "de-  
22 partment".

23 Sec. 4. Section four hundred sixty-seven A point six  
24 (467A.6), Code 1966, as amended by chapter two hundred sixty-  
25 three (263), section one (1), Acts of the Sixty-third General  
26 Assembly, First Session, is hereby further amended as follows:

27 1. By striking from line nine (9) the word "committee" and  
28 inserting in lieu thereof the word "department".

29 2. By striking from lines eleven (11) and twelve (12) the  
30 word "committee" and inserting in lieu thereof the word "de-  
31 partment".

32 3. By striking from lines twenty-five (25) and twenty-six  
33 (26) the words "state soil conservation committee" and insert-  
34 ing in lieu thereof the words "department of soil conservation".

35 Sec. 5. Section four hundred sixty-seven A point ten

1 (467A.10), Code 1966, is hereby amended by striking from line  
2 sixteen (16) the word "it" and inserting in lieu thereof the  
3 words "the department".

4 Sec. 6. Section four hundred sixty-seven A point twelve  
5 (467A.12), Code 1966, is hereby amended as follows:

6 1. By striking from line eleven (11) the word "its" and  
7 inserting in lieu thereof the word "the".

8 2. By inserting in line twelve (12) before the period the  
9 words "of the committee and department".

10 Sec. 7. Section four hundred sixty-seven A point eighteen  
11 (467A.18), Code 1966, is hereby amended by striking from lines  
12 eight (8) and nine (9) the words "state soil conservation com-  
13 mittee" and inserting in lieu thereof the words "department of  
14 soil conservation".

15 Sec. 8. Chapter one hundred fourteen (114), section three  
16 (3), Acts of the Sixty-second General Assembly, is hereby  
17 amended by inserting before the period in line fifteen (15)  
18 the words ", who may be either a member of the committee, or  
19 the director or a member of the staff of the department of  
20 soil conservation".

21 Sec. 9. Chapter two hundred sixty-two (262), section one (1),  
22 Acts of the Sixty-third General Assembly, First Session, is  
23 hereby amended by striking from line fourteen (14) the words  
24 "state soil conservation committee" and inserting in lieu there-  
25 of the words "department of soil conservation".

26 Sec. 10. Chapter two hundred sixty-three (263), section one  
27 (1), Acts of the Sixty-third General Assembly, First Session,  
28 is hereby amended as follows:

29 1. By striking from line six (6) the words "state soil con-  
30 servation committee" and inserting in lieu thereof the words  
31 "department of soil conservation".

32 2. By striking from line seven (7) the word "committee"  
33 and inserting in lieu thereof the word "department".

34 3. By striking from line (9) the word "committee" and  
35 inserting in lieu thereof the word "department".

EXPLANATION

Both the agency created by the soil conservation districts law, appearing as chapter 467A of the Code, and the governing body to which the agency is responsible, are presently known in law as the State Soil Conservation Committee. This bill redesignates the agency as the Department of Soil Conservation. The governing body will continue to be known as the State Soil Conservation Committee.
