## A BILL FOR

- 1 An Act legalizing prior judgments and decrees.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section five hundred eighty-seven point three
- 4 (587.3), Code 1966, is hereby amended by striking from line two
- 5 (2) the figures "1953" and inserting in lieu thereof the figures
- 6 "1963".
- 7 Sec. 2. Section five hundred eighty-seven point four (587.4),
- 8 Code 1966, is hereby amended by striking from line four (4) the
- 9 figures "1960" and inserting in lieu thereof the figures "1969".
- 10 Sec. 3. Section five hundred eighty-seven point seven
- 11 (587.10), Code 1966, is hereby amended by striking from line three
- 12 (3) the figures "1956" and inserting in lieu thereof the figures
- 13 "1966".
- 14 Sec. 4. Section five hundred eighty-seven point eight (587.8),
- 15 Code 1966, is hereby amended by striking from line two (2) the
- 16 figures "1955" and inserting in lieu thereof the figures "1966".
- 17 Sec. 5. Section five hundred eighty-seven point nine (587.9),
- 18 Code 1966, is hereby amended by striking from line two (2) the
- 19 figures "1959" and inserting in lieu thereof the figures "1969".
- 20 Sec. 6. Section five hundred eighty-seven point ten (587.10),
- 21 Code 1966, is hereby amended by striking from line five (5) the
- 22 figures "1960" and inserting in lieu thereof the figures "1970".
- 23 Sec. 7. Section five hundred eighty-seven point twelve
- 24 (587.12), Code 1966, is hereby amended as follows:
- 25 1. By striking from subsection one (1), line three (3), the

1 word and figures "July 4, 1961" and inserting in lieu thereof

2 the word and figures "July 1, 1970".

3 2. By striking from subsection two (2), line six (6), the

4 word and figures "July 4, 1961" and inserting in lieu thereof

5 the word and figures "July 1, 1970".

6 3. By striking from subsection three (3), line seven (7),

7 the word and figures "July 4, 1961" and inserting in lieu thereof

8 the word and figures "July 1, 1970."

9 Sec. 8. This Act shall not affect pending litigation nor

10 shall it operate to revive the rights or claims previously

11 barred nor permit an action to be brought or maintained upon any

12 claim or cause of action which is barred by any statute which

13 is in force prior to July 1, 1970, nor shall it affect any

14 action which may be brought on or before January 1, 1971.

#### EXPLANATION

This bill extends the dates of previous legalizing Acts relating to judgments and decrees.
