## A BILL FOR

- 1 An Act relating to the salaries of persons appointed to fill
- 2 vacancies in a public office.
- 3 *Be It Enacted by the General Assembly of the State of Iowa:*
- 4 Section 1. The governor or other appointing authority may,
- 5 when appointing or employing any person for which a salary is
- 6 specifically provided by the appropriation bill, appoint a
- 7 person to fill the vacancy at a lesser salary than that pro-
- 8 vided by the appropriation bill.

### EXPLANATION

This bill allows the governor or other appointing authority to appoint a person to fill a vacancy at a lesser salary than is specifically provided in a line item appropriation for the official being replaced.
