A BILL FOR

1 An Act relating to technical corrections required by passage
2 of the Iowa Banking Act of 1969.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Section four hundred ninety-six point thirteen
5 (496.13), Code 1966, is hereby amended by striking all of such
6 section after the word "law" in line twenty-one (21) and insert-
7 ing in lieu thereof a period.

8 Sec. 2. Section four hundred ninety-six A point one hundred
9 forty-two (496A.142), Code 1966, is hereby amended as follows:

10 1. By striking from line five (5) the figures "526, 527,
11 528, 528B, 531, 532,".

12 2. By inserting in line six (6) after the word "Code" the
13 words "and state banks organized under chapter two hundred
14 seventy-three (273), Acts of the Sixty-third General Assembly,
15 First Session".

16 Sec. 3. Section five hundred four A point one hundred
17 (504A.100), subsection one (1), Code 1966, is hereby amended
18 as follows:

19 1. By striking from lines five (5) and six (6) the figures
20 "526, 527, 528, 528B, 531, 532,".

21 2. By inserting in line six (6) before the period the words
22 "and state banks organized under chapter two hundred seventy-
23 three (273), Acts of the Sixty-third General Assembly, First Ses-
24 sion".

25 Sec. 4. Section five hundred fifty-four point nine thousand

1 two hundred three (554.9203), subsection two (2), Code 1966, is
2 hereby amended by striking from lines two (2) and three (3) the
3 figures "529, 535, and 536" and inserting in lieu thereof the
4 words and figures "five hundred thirty-five (535), five hundred
5 thirty-six (536), and chapter two hundred seventy-three (273),
6 section nine hundred six (906), Acts of the Sixty-third General
7 Assembly, First Session,".

8 Sec. 5. Section six hundred thirty-three point two hundred
9 three (633.203), Code 1966, is hereby amended by striking from
10 line four (4) the word and figure "chapter 532" and inserting
11 in lieu thereof the words and figures "chapter two hundred
12 seventy-three (273), division ten (X), Acts of the Sixty-third
13 General Assembly, First Session".

14 Sec. 6. Section six hundred eighty-two point forty-seven
15 (682.47), Code 1966, as amended by chapter four hundred (400),
16 section two hundred twenty-two (222), Acts of the Sixty-second
17 General Assembly, is hereby further amended by striking lines
18 twenty-two (22) through twenty-five (25), inclusive.

19 Sec. 7. Chapter two hundred seventy-three (273), Acts of the
20 Sixty-third General Assembly, First Session, is hereby amended
21 as follows:

22 1. By striking from section two hundred eighteen (218),
23 lines three (3) and four (4), the brackets and inserting in
24 lieu thereof commas.

25 2. By striking from section three hundred two (302), line
26 twenty-seven (27), the word "persons" and inserting in lieu
27 thereof the word "individuals".

28 3. By striking from section six hundred one (601), line
29 five (5), the word "person" and inserting in lieu thereof the
30 word "individual".

31 4. By striking from section six hundred twelve (612), line
32 thirty-three (33), the parenthesis preceding the word "other"
33 and inserting in lieu thereof a comma.

34 5. By striking from section six hundred twelve (612), line
35 thirty-five (35), the parenthesis and inserting in lieu thereof

- 1 a comma.
- 2 6. By striking from section seven hundred two (702), lines
3 sixteen (16), and seventeen (17), the words "a trust" and in-
4 serting in lieu thereof the words "an escrow".
- 5 7. By striking from section eight hundred six (806), line
6 six (6), the word "person" and inserting in lieu thereof the
7 word "individual".
- 8 8. By inserting in section nine hundred four (904), line
9 thirteen (13), after the word "partnership" the words "or other
10 unincorporated association".
- 11 9. By inserting in section nine hundred four (904), line
12 nineteen (19), after the word "owns" the words "or controls".
- 13 10. By inserting in section nine hundred four (904), line
14 twenty-two (22), after the word "owns" the words "or controls".
- 15 11. By striking from section nine hundred four (904), line
16 one hundred thirteen (113), the word "estate" and inserting in
17 lieu thereof the word "property".
- 18 12. By striking from section one thousand three hundred
19 four (1304), line twenty-two (22), the word and figures "seven
20 (1307)" and inserting in lieu thereof the word and figures
21 "eight (1308)".
- 22 13. By striking from section one thousand four hundred two
23 (1402), line seventy-one (71), the word "persons" and inserting
24 in lieu thereof the word "individuals".
- 25 14. By striking from section one thousand four hundred two
26 (1402), line seventy-eight (78), the word and figure "nine (9)".
- 27 15. By striking from section one thousand four hundred
28 eleven (1411), line seventeen (17), the word and figure "nine
29 (9)".
- 30 16. By striking from section one thousand five hundred four
31 (1504), line three (3), the word "supplied" and inserting in
32 lieu thereof the word "prescribed".
- 33 17. By striking from section one thousand five hundred four
34 (1504), line six (6), the words "and post office address".
- 35 18. By striking from section one thousand six hundred one

- 1 (1601), lines six (6) and seven (7), the brackets and inserting
- 2 in lieu thereof commas.

EXPLANATION

This bill is necessary to make corrections in language and style, and to correct internal cross-references, in the Iowa Banking Act of 1969 (chapter 273, Acts of the Sixty-third General Assembly, First Session), and certain related provisions of the 1966 Code of Iowa.
