- 6 (321A.3), Code 1966, lines eleven (11) and twelve (12), is
- 7 hereby amended by striking the words "of one dollar shall be
- 8 paid for each such abstract" and inserting in lieu thereof
- 9 the words "in an amount sufficient to cover the costs of
- 10 preparing, certifying, and mailing such abstract shall be
- 11 paid,".

At present the fee for furnishing copies of a driving record is one dollar. This fee does not pay the administrative expense. This bill makes the fee an amount sufficient to cover the cost.
