A BILL FOR

- 1 An Act relating to the state educational radio and television
- 2 facility board.
- 3 *Be It Enacted by the General Assembly of the State of Iowa:*
- 4 Section 1. Chapter eighty-eight (88), Acts of the Sixty-
- 5 second General Assembly, is hereby amended by adding the follow-
- 6 ing new section:
- 7 "The state educational radio and television facility board
- 8 may locate its administrative offices and production facilities
- 9 outside the city of Des Moines, Iowa, and on land not owned by
- 10 the state board."

EXPLANATION

Chapter 20, Acts of the Sixty-third General Assembly, First Session, appropriated \$50,000 for the preparation of detailed design plans and architectural and engineering services for future development of a central network production center. It is the desire of the State Board to locate this facility on land owned by the Area XI Community College at Ankeny, Iowa. The Attorney General's Office has ruled that before the Board can move out of the city of Des Moines, the express permission of the Legislature would be required. The architects have also indicated that before they can finish the plans called for by the above mentioned appropriation that they need to know exactly where the facility is to be located. The passage of this bill would grant the Educational Radio and Television Facility Board the express permission to locate outside the city of Des Moines, Iowa.
