3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Chapter fifty-two (52), section one (1), Acts
5 of the Sixty-third General Assembly, First Session, is hereby
6 amended by inserting on line six (6), after the period the
7 following:

8 "Each year of the biennium beginning July 1, 1969, and end-
9 ing July 1, 1971, the sum of thirty thousand (30,000) dollars, or
10 so much thereof as is necessary, may be used from the appropria-
11 tion to pay expenses and costs of administration of the tuition
12 grant program."

13 Sec. 2. This Act being deemed of immediate importance shall
14 be in full force and effect from and after its final approval
15 and publication in the,

This bill provides administrative funds for the administration of the tuition grant program.
