A BILL FOR

1 An Act to co-ordinate various statutes with the Act creating
2 the department of revenue.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Chapter three hundred forty-two (342), Acts of
5 the Sixty-second General Assembly, section twenty-four (24),
6 line thirty-five (35), is amended by inserting after the
7 figures "(17)" the words "of subsection six (6)".

8 Sec. 2. Chapter three hundred forty-two (342), Acts of the
9 Sixty-second General Assembly, section forty-three (43), is
10 amended by striking all of subsection one (1).

11 Sec. 3. Chapter three hundred forty-two (342), Acts of the
12 Sixty-second General Assembly, section forty-four (44), is re-
13 pealed.

14 Sec. 4. Chapter three hundred forty-two (342), Acts of the
15 Sixty-second General Assembly, section forty-five (45), is
16 amended by striking all of subsection two (2).

17 Sec. 5. Chapter three hundred forty-two (342), Acts of the
18 Sixty-second General Assembly, is amended by striking section
19 forty-seven (47).

20 Sec. 6. Chapter three hundred forty-two (342), Acts of the
