A BILL FOR

1 An Act to amend chapter seventy-four (74), Acts of the Sixty-
2 second General Assembly.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Chapter seventy-four (74), Acts of the Sixty-
5 second General Assembly, is hereby amended as follows:

6 1. By striking in line four (4) of section one (1), the
7 word "chapel" and inserting in lieu thereof the words
8 "memorial hall".

9 2. By striking in line two (2) of section two (2), the
10 figures "1969" and inserting in lieu thereof the figures
11 "1971".

12 3. By striking from the title the word "chapel" and
13 inserting in lieu thereof the words "memorial hall".

14 4. This Act, being deemed of immediate importance,
15 shall be in full force and effect from and after its passage

- 2 at Earlham, Iowa, and in The Cedar Rapids Gazette, a
- 3 newspaper published at Cedar Rapids, Iowa.

This bill amends an Act passed by the Sixty-second General Assembly, and provides for an appropriation for the construction of a Memorial Hall at Camp Dodge.
