## A BILL FOR

*Sub. for 21. 7. 391  
4-18*

- 1 An Act relating to the compensation of insurance examiners.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section five hundred seven point four (507.4),
- 4 Code 1966, is hereby amended as follows:
- 5 1. By striking from line eighteen (18) the words "per
- 6 diem" and inserting in lieu thereof the word "salary".
- 7 2. By striking from lines nineteen (19) through twenty-
- 8 one (21) the words "which shall be in such amount as not
- 9 to exceed the aggregate sum of two hundred dollars per week".
- 10 3. By striking lines twenty-two (22) through twenty-
- 11 eight (28), inclusive, and inserting in lieu thereof the
- 12 words "the provisions of section five hundred five point
- 13 fourteen (505.14). Said compensation shall be".
- 14 Sec. 2. Section five hundred seven point six (507.6),
- 15 Code 1966, is hereby amended by striking the remainder of
- 16 such section after the word "examiner" in line eight (8)
- 17 and inserting in lieu thereof a period.
- 18 Sec. 3. Section five hundred seven point eight (507.8),
- 19 Code 1966, is hereby amended by striking lines one (1) through
- 20 three (3), inclusive, and inserting in lieu thereof the
- 21 words "The commissioner shall upon the completion of an
- 22 examination prepare an account of the costs incurred in
- 23 performing and preparing the report of such examinations
- 24 which shall be".
- 25 Sec. 4. Section five hundred seven point nine (507.9),

- 1 Code 1966, is hereby amended by striking from line five
- 2 (5) the words "as are other fees of his office".

EXPLANATION OF SENATE FILE 285

This bill relating to the compensation of insurance examiners amends the present provisions by substituting a salary for per diem payment of examiners. It further removes the two hundred dollars per week ceiling on the compensation of such examiners.
