A BILL FOR

1 An Act relating to roadside parks.

2 *Be It Enacted by the General Assembly of the State of Iowa:*

3 Section 1. Section three hundred thirteen point two (313.2),

4 Code 1966, is hereby amended by striking lines forty-one (41)

5 through fifty-six (56) and inserting in lieu thereof the follow-

6 ing:

7 "The state highway commission either alone or in coopera-

8 tion with any county shall have authority to cause the con-

9 struction, reconstruction, improvement, and maintenance of

10 roadside safety rest and information areas, including struc-

11 tures necessary and incident thereto, along the controlled

12 access facilities and other primary roads of the state includ-

13 ing the acquisition of such property and property rights needed

14 to accomplish such purposes. The commission shall also have

15 the authority to accept by gift, equipment and other installa-

16 tions incidental to said use, and shall be empowered on behalf

17 of the state to enter into any agreements with duly constituted

18 authorities in order to secure the benefit of all present or

19 future federal allotments for said purpose. Roadside safety

20 rest and information areas shall be a part of the primary and

21 secondary road system."
