A BILL FOR

1 An Act relating to election returns.

2 *Be It Enacted by the General Assembly of the State of Iowa:*

3 Section 1. Section fifty point sixteen (50.16), Code

4 1966, is hereby amended as follows:

5 1. By striking from line one (1) the words "A return"

6 and inserting in lieu thereof the words "The tally list".

7 2. By striking from lines two (2) and three (3) the

8 words "words written at length" and inserting in lieu

9 thereof the words "legibly printed numerals".

10 3. By striking from line seven (7) the word "return"

11 and inserting in lieu thereof the words "tally list".

12 4. By striking from line seventeen (17) the word

13 "return" and inserting in lieu thereof the words "tally

14 list".

15 Sec. 2. Section fifty point seventeen (50.17), Code

16 1966, is hereby amended by striking from line three (3)

17 the word "return" and inserting in lieu thereof the words

18 "tally list".

19 Sec. 3. Section fifty point twenty (50.20), Code 1966,

20 is hereby amended by striking from line five (5) the word

21 "returns" and inserting in lieu thereof the words "tally

22 lists".

EXPLANATION OF SENATE FILE 340

This bill will eliminate the election return from poll books. Only the tally list will be used and the judges of the election will sign an affidavit attached to this list certifying that the tally list is a true and correct record of the election results.
