A BILL FOR

1 An Act to legalize and validate the special election held in
2 Pottawattamie County, Iowa on the 5th day of November, 1968
3 on the proposition of remodeling the present County home and
4 build and equip an addition thereto.

5 WHEREAS, on the 1st day of October, 1968, the Board of
6 Supervisors of Pottawattamie County, State of Iowa, called a
7 special election in said county for November 5, 1968 on the
8 following question:

9 Shall the County of Pottawattamie, in the State of Iowa
10 remodel the present County Home located at McClelland, Iowa,
11 and build and equip an addition to said County Home, located
12 at McClelland, Iowa, at a total cost not to exceed \$70,000.00,
13 and in order to pay the cost thereof to levy a tax in addition
14 to all other taxes, for the year 1969, due and payable in 1970,
15 on all taxable property within said county, not to exceed
16 \$70,000.00 and not to exceed $\frac{1}{4}$ of one per cent on the county
17 taxable valuation, and

18 WHEREAS, at said election the proposition was approved by
19 more than 60 per cent of the total votes cast for or against
20 said proposition, and

21 WHEREAS, due to an oversight, notice of election was pub-
22 lished only once, when the statute of the State of Iowa re-
23 quires four separate publications of said special election and
24 it is advisable to put any doubts of the sufficiency of said
25 notice and any other doubts concerning said special election

1 forever at rest; NOW THEREFORE,
2 *Be It Enacted by the General Assembly of the State of Iowa:*
3 Section 1. That all proceedings heretofore taken by the
4 Board of Supervisors of Pottawattamie County, State of Iowa,
5 pursuant to and in connection with the call of the special
6 election held on November 5, 1968 for the submission of the
7 proposition to remodel, build and equip an addition to the
8 said county home located at McClelland, Iowa at a total cost
9 not to exceed Seventy thousand Dollars and in order to pay the
10 cost thereof, to levy a tax in addition to all other taxes for
11 the year 1969 due and payable in 1970 on all taxable property
12 within said county not to exceed Seventy thousand Dollars and
13 not to exceed one-fourth of one per cent on the county taxable
14 valuation; including also the notice of election publication
15 of said election notice, the sufficiency of said election notice,
16 the election ballot, the election staff and the adoption of said
17 proposition at said election by the voters of Pottawattamie
18 County, State of Iowa, are hereby legalized, validated and con-
19 firmed and shall constitute full authority by the Board of
20 Supervisors of Pottawattamie County, State of Iowa to levy a
21 tax not to exceed one-fourth of one per cent on the County
22 taxable valuation, and in an amount not to exceed Seventy thou-
23 sand Dollars, and that said election is hereby declared to be
24 legal and to constitute a valid and binding election.
25 Sec. 2. This act being deemed of immediate importance shall
26 take effect and be in force from and after its publication in
27 the Neola-Gazette Reporter, a newspaper published in Neola,
28 Iowa, and in the Council Bluffs Nonpareil, a newspaper pub-
29 lished in Council Bluffs, Iowa.

EXPLANATION OF SENATE FILE 347

This bill legalizes the proceedings whereby a special election was held in Pottawattamie county on the proposition of remodeling the county home and building and equipping an addition to such county home.
