A BILL FOR

- 1 An Act relating to benefited water districts.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section three hundred fifty-seven point nine-
- 4 teen (357.19), Code 1966, is hereby amended as follows:
- 5 1. By striking from line fifteen (15) the word "assessed"
- 6 and inserting in lieu thereof the word "actual".
- 7 2. By striking all of such section after the period in
- 8 line nineteen (19).

EXPLANATION OF SENATE FILE 407

This bill will eliminate the limitation of cost per lineal foot of assessments against property for water improvement, but preserve a limitation of such assessments to 25 percent of the value of the property.

1 Amend Senate File 407 by striking lines five (5) through
2 eight (8), inclusive, and inserting in lieu thereof the fol-
3 lowing:

4 "1. By striking from lines eight (8) and nine (9) the
5 words 'be made according to benefits' and inserting in lieu
6 thereof the words 'not exceed benefits conferred'.

7 2. By inserting in line eleven (11) after the period the
8 following:

9 'Where a pipe in excess of six inches in diameter is used,
10 the assessment against the abutting property shall be limited
11 to the cost of a six inch pipe, and the difference between the
12 cost of the pipe used and a six inch pipe shall be paid by a
13 uniform assessment against all benefited property within the
14 water district.'

15 3. By striking from line fifteen (15) the word 'assessed'
16 and inserting in lieu thereof the word 'actual'.

17 4. By striking all of such section after the period in
18 line nineteen (19)."
