- 1 An Act relating to use tax.
- 2 *Be It Enacted by the General Assembly of the State of Iowa:*
- 3 Section 1. Section four hundred twenty-three point two
- 4 (423.2), Code 1966, as amended by chapters three hundred forty-
- 5 two (342) and three hundred forty-eight (348), Acts of the
- 6 Sixty-second General Assembly, is hereby further amended by
- 7 inserting in line nine (9) after the word "treasurer" the words
- 8 "or department of public safety".
- 9 Sec. 2. Section four hundred twenty-three point six
- 10 (423.6), subsection one (1), Code 1966, is hereby amended by
- 11 inserting in line six (6) after the word "treasurer" the words
- 12 "or department of public safety".
- 13 Sec. 3. Section four hundred twenty-three point seven
- 14 (423.7), Code 1966, is hereby amended as follows:
- 15 1. By inserting in line four (4) after the word "treasurer"
- 16 the words "or department of public safety".
- 17 2. By inserting in line nine (9) after the word "treasurer"
- 18 the words "or department of public safety".
- 19 3. By inserting in line eighteen (18) before the word
- 20 "shall" the words "or department of public safety".

EXPLANATION OF SENATE FILE 536

The Department of Public Safety is not mentioned in section 423 of the Code. This department performs the same collecting as the county treasurers. (See Rule No. 234 of the IDR.) Updating of the Code will eliminate the rule and any question as to the "Powers and Duties of the Motor Vehicle Division, Department of Public Safety of Iowa".

16 is hereby further amended by adding the following new subsection:
17 "7. Advertising and promotional material and envelopes for same,
18 temporarily stored in this state which are acquired outside of Iowa
19 and subsequently sent outside of Iowa."
