A BILL FOR

1 An Act relating to payment by school boards of dues to an
2 association of school boards and of expenses of board
3 members.

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. Chapter two hundred seventy-nine (279), Code
6 1966, is hereby amended by adding thereto the following new
7 section:

8 "Boards of directors of school corporations may pay, out
9 of funds available to them, reasonable annual dues to an
10 Iowa association of school boards."

11 Sec. 2. Section two hundred seventy-nine point twenty-
12 nine (279.29), Code 1966, is hereby amended by adding to the
13 end thereof the following:

14 "Actual and necessary expenses, including travel, incurred
15 by the board or individual members thereof in the performance
16 of official duties may be paid or reimbursed."

EXPLANATION OF SENATE FILE 545

This bill allows school boards to pay dues to an association of school boards. It also allows school board members to receive payment for actual and necessary expenses, including travel, incurred in the performance of their official duties.

23 "Boards of directors of merged area schools may pay,
24 out of funds available to them, reasonable annual dues to
25 an Iowa association of school boards.
26 Membership in such an Iowa association of school
27 boards shall be limited to those duly elected members of
28 boards of directors of area schools."

5 student attending the public school in the school district."

7 "Sec. 3. The books of the Iowa School Board Association
8 shall be presented to the office of the auditor of state not
9 later than January 31 of each year for the purpose of an audit
10 by the office of the auditor of state."
