## A BILL FOR

1 An Act to appropriate from the general fund of the state of  
2 Iowa for the biennium beginning July 1, 1969 and ending  
3 June 30, 1971, to various departments and various divisions  
4 thereof of the state of Iowa.

5 *Be It Enacted by the General Assembly of the State of Iowa:*

6 Section 1. For the following departments there is hereby  
7 appropriated from the general fund of the state for each year  
8 of the biennium beginning July 1, 1969 and ending June 30, 1971,  
9 the following amounts, or so much thereof as may be necessary,  
10 to be used in the manner designated:

11 1. BLIND, IOWA COMMISSION FOR THE

12 For salaries, support, maintenance and  
13 miscellaneous purposes (including a salary  
14 of seventeen thousand (17,000) dollars for  
15 the director) .....\$362,460.00

16 For the training and education of  
17 multiple handicapped blind children ..... 10,000.00

18 Total .....\$372,460.00

19 2. HIGHER EDUCATION FACILITIES COMMISSION

20 For salaries, support, maintenance and  
21 miscellaneous purposes .....\$ 65,240.00

22 3. SOLDIERS' BONUS BOARD, WORLD WAR

23 ORPHANS' EDUCATION AID

24 For the purpose of administration and  
25 aiding in the education of children of

1 honorably discharged soldiers, sailors,  
 2 marines, nurses, or other component part  
 3 of the military forces of this state or  
 4 nation as specified in section thirty-five  
 5 point nine (35.9), Code 1966 .....\$ 55,000.00  
 6 Grand total of all appropriations for  
 7 each year of the biennium provided by  
 8 section one (1) of this Act .....\$492,700.00  
 9 Sec. 2. All federal grants to and the federal receipts of  
 10 these departments and divisions thereof are hereby appropriated  
 11 for the purpose set forth in such federal grants or receipts.  
 12 Sec. 3. No moneys appropriated by this Act shall be used  
 13 for capital improvements.  
 14 Sec. 4. Where any of the laws of this state are in conflict  
 15 with this Act, the provisions of this Act shall govern for the  
 16 biennium.

 8 hereby made applicable to this Act."  
 9 3. By renumbering section 4 as section 5.
