## A BILL FOR

1 An Act to legalize and validate the special election of the  
2 Madrid Community School District, in the Counties of Boone,  
3 Polk and Dallas, State of Iowa, held on September 30,  
4 1968, on the proposition of issuing School Bonds in the  
5 sum of not to exceed \$755,000.00 for the purpose of build-  
6 ing and furnishing a senior high school building and  
7 gymnasium and acquiring land therefor and for future  
8 school buildings.

9 WHEREAS, on the 23rd day of August, 1968, the Board of  
10 Directors of the Madrid Community School District, in the  
11 Counties of Boone, Polk and Dallas, State of Iowa, called a  
12 special election of said District for September 30, 1968, on  
13 the following question:

14 "Shall the Madrid Community School District, in the Counties  
15 of Boone, Polk and Dallas, State of Iowa, issue School Bonds  
16 in the sum of not to exceed \$755,000.00 for the purpose of  
17 building and furnishing a senior high school building and  
18 gymnasium and acquiring land therefor and for future school  
19 buildings?"

21 WHEREAS, at said election the proposition was approved by  
22 more than sixty percent of the total votes cast for or against  
23 said proposition; and as, doubts have arisen concerning the  
24 validity and legal sufficiency of said election and it is  
25 advisable to put such doubts and all other doubts that might

1 arise concerning such election forever at rest; NOW, THERE-  
2 FORE,

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. All proceedings heretofore taken by the Board  
5 of Directors of the Madrid Community School District, in the  
6 Counties of Boone, Polk and Dallas, State of Iowa, pursuant  
7 to and in connection with the call of the special election  
8 held on September 30, 1968, for the submission of the said  
9 proposition of issuing School Bonds of the sum of not to  
10 exceed \$755,000.00 for the purpose of building and furnishing  
11 a senior high school building and gymnasium and acquiring  
12 land therefor and for future school buildings; including also  
13 the notice of election, the publication of said election  
14 notice, the election ballot, the election staff, and the  
15 adoption of said proposition at said election by the voters  
16 of said School District, are hereby legalized, validated and  
17 confirmed, and shall constitute full authority by the Board  
18 of Directors of said School District to issue and sell said  
19 bonds for the aforesaid proposition authorized at said elec-  
20 tion in an amount not to exceed \$755,000.00, and said bonds,  
21 when issued, shall constitute valid and binding obligations  
22 of said School District.

23 Sec. 2. This Act being deemed of immediate importance  
24 shall be in full force and effect from and after its passage  
25 and publication in the .....,  
26 a newspaper published in .....,  
27 ....., Iowa, and in .....,  
28 ....., a newspaper published in .....,  
29 Iowa, all without expense to the State of Iowa.
