1-12 Motion to reconsider filed

- 1 An Act relating to fees charged for licenses of motor vehicle
- 2 manufacturers, distributors, wholesalers, factory repre-
- 3 sentatives, and distributor branch representatives.
- 4 *Be It Enacted by the General Assembly of the State of Iowa:*
- 5 Section 1. Section three hundred twenty-two point twenty-
- 6 nine (322.29), Code 1966, is hereby amended as follows:
- 7 1. By striking from line eighteen (18) the word "five"
- 8 and inserting in lieu thereof the word "ten".
- 9 2. By striking from line twenty (20) the word "five" and
- 10 inserting in lieu thereof the word "ten".
- 11 3. By striking from line twenty-two (22) the word "two"
- 12 and inserting in lieu thereof the word "five".

EXPLANATION OF SENATE FILE 594

This bill raises the license fees for motor vehicle manufacturers, and for factory branches of such manufacturers in this state, and for motor vehicle distributors or wholesalers from five to ten dollars. It also raises the license fees for factory representatives and distributor's branch representatives from two to five dollars.
