## A BILL FOR

1 An Act to appropriate from the general fund of the state of  
2 Iowa for capital improvements for institutions under the  
3 department of social services, including construction of  
4 new buildings, repairs, improvements, replacements or  
5 alterations.

6 *Be It Enacted by the General Assembly of the State of Iowa:*

7 Section 1. There is hereby appropriated from the general  
8 fund of the state of Iowa to the department of social services  
9 the sum of two million two hundred thousand (2,200,000) dollars  
10 to be used in the following manner, to wit:

11 1. Youth forest camp .....\$ 460,000.00

12 The department of social services may enter into agreements  
13 to lease or use state owned lands under the jurisdiction of  
14 the state conservation commission and is hereby authorized to  
15 construct, operate and maintain a youth camp under arrangements  
16 between the two departments.

17 2. To supplement any prior appropriations for capital im-  
18 provement items for construction of new buildings, repairs,  
19 improvements, replacements or alterations, or for any capital  
20 expenditures the department of social services may deem neces-  
21 sary for the proper and necessary function of any institution  
22 under its jurisdiction..... 1,740,000.00

## A BILL FOR

1 An Act to appropriate from the general fund of the state of

24 Sec. 2. Contracts for improvements for which funds are  
25 appropriated by this Act shall be submitted by the department

1 of social services to the governor and the state comptroller,  
2 except that items commonly known as change orders need not  
3 be submitted to the governor and the state comptroller unless  
4 such change orders actually increase the total cost of that  
5 particular project.

6 Sec. 3. Upon completion of the contract documents and the  
7 determination of the total cost of any project as set forth  
8 in this Act, any unobligated balance remaining may be used to  
9 supplement any current or prior appropriation for capital im-  
10 provement items for construction of new buildings, repairs,  
11 improvements, replacements or alterations, or for any other  
12 capital expenditures the department of social services may  
13 deem necessary for proper and necessary function of any in-  
14 stitution under its jurisdiction.

15 Sec. 4. The department of social services, the governor  
16 and the state comptroller are hereby authorized to obtain  
17 federal grants to the state to be used in connection with the  
18 funds appropriated by this Act.

19 Sec. 5. Any unencumbered balance remaining as of June 30,  
20 1973, of the appropriation of this Act shall revert to the  
21 general fund of the state as of June 30, 1973.
