A BILL FOR

1 An Act relating to the Iowa merit employment department and
2 to make an appropriation thereto.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. Chapter ninety-five (95), section eight (8),
5 Acts of the Sixty-second General Assembly, is hereby amended
6 by adding the following thereto:

7 "The director shall monthly render a statement to those
8 covered departments which operate in whole or in part from
9 other than general fund appropriations for a prorata share
10 of the cost of administration of the merit employment de-
11 partment. Such expense shall be paid by the state depart-
12 ments or agencies in the same manner as other expenses of
13 such department are paid and shall constitute a 'repayment
14 receipt' to the merit employment department."

15 Sec. 2. There is hereby appropriated from the general
16 fund of the state for each year of the biennium beginning
17 July 1, 1969 and ending June 30, 1971, to the Iowa merit
18 employment department the sum of two hundred twenty-four
19 thousand (224,000) dollars, or so much thereof as may be
20 necessary, for salaries, support, maintenance and miscel-
21 laneous purposes, including a salary of seventeen thousand
22 (17,000) dollars for the director.

23 Sec. 3. All federal grants to and the federal receipts
24 of this department are hereby appropriated for the purpose
25 set forth in such federal grants or receipts.

- 1 Sec. 4. Where any of the laws of this state are in conflict
- 2 with this Act, the provisions of this Act shall govern for the
- 3 biennium.
