A BILL FOR

1 An Act to appropriate from the general fund of the state to
2 the state conservation commission.

3 *Be It Enacted by the General Assembly of the State of Iowa:*

4 Section 1. There is hereby appropriated for the state
5 conservation commission from the general fund of the state
6 of Iowa for each year of the biennium beginning July 1, 1969
7 and ending June 30, 1971, the following amounts, or so much
8 thereof as may be necessary, to be used in the manner desig-
9 nated:

10 1. LANDS AND WATERS OPERATIONS

11 For salaries, support, maintenance and
12 miscellaneous purposes of the office,
13 maintenance of state parks, waters and
14 forests, and dredging, including not more
15 than four hundred twenty-seven thousand
16 three hundred ninety (427,390) dollars
17 which shall be available for the adminis-
18 tration fund in compliance with the pro-
19 visions of section one hundred seven point
20 seventeen (107.17) of the Code\$1,500,940.00

21 From said one million five hundred
22 thousand nine hundred forty (1,500,940)
23 dollars there shall be paid during the
24 first year of the biennium to the state
25 conservation director appointed in June

1 of 1968, for reimbursement of moving
 2 expenses incurred in moving to the state
 3 of Iowa and the city of Des Moines, the
 4 sum of six hundred seventy-four dollars
 5 and forty-four cents (674.44).

6 2. PRISON LABOR PROGRAM

7 For salaries, support, maintenance and
 8 miscellaneous purposes for utilization of
 9 prison and training school inmates, in-
 10 cluding a youth forest camp in conjunction
 11 with the department of social services\$ 123,630.00

12 3. STATE ADVISORY BOARD FOR PRESERVES

13 For salaries, support, maintenance and
 14 miscellaneous purposes for carrying out
 15 the duties of the board\$ 15,000.00

16 4. PLANNING AND COOPERATION WITH
 17 FEDERAL AGENCIES ON CONSERVATION

18 For salaries, support, maintenance
 19 and miscellaneous purposes\$ 64,140.00

20 Total\$1,703,710.00

21 Sec. 2 The salary of the state conservation director shall
 22 be seventeen thousand five hundred (17,500) dollars for each year
 23 of the biennium.

24 Sec. 3. All federal grants to and the federal receipts of the
 25 commission are hereby appropriated for the purpose set forth in
 26 such federal grants or receipts.

27 Sec. 4. No moneys appropriated by this Act shall be used for
 28 capital improvements.

29 Sec. 5. The provisions of chapter eight (8), of the Code,
 30 shall apply to this Act.

31 Sec. 6. Where any of the laws of this state are in conflict
 32 with this Act, the provisions of this Act shall govern for the
 33 biennium.
