*Committee Report
Adopted 5-19*

1 An Act to appropriate general and vocational education adminis-
2 tration funds from the general fund of the state to the de-
3 partment of public instruction.

4 *Be It Enacted by the General Assembly of the State of Iowa:*

5 Section 1. There is hereby appropriated from the general
6 fund of the state to the department of public instruction for
7 each year of the biennium beginning July 1, 1969 and ending
8 June 30, 1971, the following amounts, or so much thereof as
9 may be necessary, to be used for the purposes designated:

10 1. GENERAL OFFICE ADMINISTRATION

11 For salaries, support, maintenance, and
12 miscellaneous purposes\$1,118,840.00

13 2. VOCATIONAL EDUCATION ADMINISTRATION

14 For salaries, support, maintenance, and
15 miscellaneous purposes\$ 233,380.00

16 3. VOCATIONAL REHABILITATION

17 For salaries, support, maintenance, and
18 miscellaneous purposes\$1,000,000.00

19 Sec. 2. No moneys appropriated by the Act shall be used
20 for capital improvements.

21 Sec. 3. The provisions of chapter eight (8) of the Code
22 shall apply to this Act.

23 Sec. 4. Where any of the laws of this state are in conflict
24 with this appropriation Act, the provisions of this Act shall
25 govern for the biennium.

1 Sec. 5. Section two hundred fifty-seven point twenty-four
 2 (257.24), Code 1966, is hereby amended by striking from lines
 3 two (2) and three (3) the words "general assembly" and insert-
 4 ing in lieu thereof the words "state board".

1 Amend the Balloun amendment filed May 5, 1969, to Senate
 2 File 679 as follows:
 3 In Section 1, by striking the words "twenty-three thousand
 4 dollars" and inserting in lieu thereof the words "twenty-two
 5 thousand dollars."
