A BILL FOR

1 An Act to legalize the indebtedness of the Audubon County
2 Agricultural Society and to provide an annual tax to pay
3 said indebtedness.

4 WHEREAS, the Audubon County Agricultural Society has made
5 improvements on the county fairgrounds to the extent of ap-
6 proximately \$43,000 and has become indebted therefor; and

7 WHEREAS, said improvements were made in reliance on ob-
8 taining the one-fourth mill levy authorized by section one
9 hundred seventy-four point seventeen (174.17) of the Code,
10 and

11 WHEREAS, the said levy must be approved annually by the
12 board of supervisors and a quarter-mill levy produces about
13 \$9,000, and since the debt is \$43,000, it will take several
14 years to pay the indebtedness; and

15 WHEREAS, since there can be no assurance that the board
16 of supervisors will continue the levy, lending agencies are
17 reluctant to provide funds to pay the indebtedness; NOW
18 THEREFORE:

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

20 Section 1. The levy of the board of supervisors of Audubon
21 county, Iowa, of one-fourth mill, under the provisions of
22 section one hundred seventy-four point seventeen (174.17)
23 of the Code, to pay the indebtedness of the Audubon County
24 Agricultural Society incurred prior to the effective date
25 of this Act is ordered to be continued annually until said

1 indebtedness, plus interest, is paid.

2 Sec. 2. This Act, being deemed of immediate importance,
3 shall take effect and be in force from and after its publica-
4 tion in the Audubon News-Advocate, a newspaper published in
5 Audubon, Iowa, and in the Audubon County Journal, a news-
6 paper published in Exira, Iowa, without expense to the state.

7 EXPLANATION

8 This bill extends the one-quarter mill levy under section
9 174.17 of the Code until improvements totaling \$43,000 on
10 the county fairgrounds of Audubon County are paid off.

9 dollar expenditure made by the Audubon county agri-
10 cultural society for improvement to the fairgrounds
11 and a levy in 1970, for the fairground fund pursuant
12 to section one hundred seventy-four point seventeen
13 (174.17) of the Code, is hereby legalized. Under the
