A BILL FOR

1 An Act to legalize and validate proceedings of the Board of
2 Directors of the United Community School District in the
3 Counties of Boone and Story, State of Iowa, authorizing
4 and providing for the sale and issuance of School Building
5 Bonds and for the levy of taxes for the payment of said
6 bonds and declaring the bonds issued pursuant to said
7 proceedings to be enforceable obligations of said School
8 District.

9 WHEREAS, it appears from the records of the Board of
10 Directors of the United Community School District in the
11 Counties of Boone and Story, State of Iowa, that at a special
12 school election held in and for said School District on November
13 15, 1971, the proposition of issuing bonds of said School
14 District in the amount of Three Hundred Ninety Thousand Dollars
15 (\$390,000) for the purpose of building and furnishing a new
16 elementary school building at the high school site in and for
17 said School District was approved by more than sixty percent
18 (60%) of the total number of votes cast for and against said
19 proposition, and in reliance upon said election, said Board
20 of Directors thereafter authorized and provided for the sale
21 and issuance of school building bonds to the amount and for
22 the purpose aforesaid and made provision for the levy of taxes
23 to pay said bonds and the interest thereon; and

24 WHEREAS, doubts have arisen concerning the validity and
25 legal sufficiency of said election and proceedings and provi-

1 sions made for the issuance and payment of said bonds, and it
 2 is deemed advisable to put such doubts and all others that
 3 might arise concerning same forever at rest; now, therefore,
 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:
 5 Section 1. That all proceedings heretofore taken by the
 6 Board of Directors of the United Community School District
 7 in the Counties of Boone and Story, State of Iowa, preliminary
 8 to and in connection with the election on said bonds held
 9 in said School District on November 15, 1971, and providing
 10 for the sale, issuance and delivery of school building bonds
 11 of said School District in the amount of Three Hundred Ninety
 12 Thousand Dollars (\$390,000) pursuant to said election, and
 13 for the levy of taxes to pay said bonds and interest thereon,
 14 are hereby legalized, validated and confirmed and said school
 15 building bonds issued, sold and delivered pursuant to and
 16 in accordance with said proceedings are hereby declared to
 17 be legal and to constitute the valid and binding obligations
 18 of said School District.

19 Sec. 2. This Act, being deemed of immediate importance,
 20 shall take effect and be in force from and after its publica-
 21 tion in the Ames Daily Tribune, a newspaper published in Ames,
 22 Iowa, and in The Boone News-Republican, a newspaper published
 23 in Boone, Iowa, without expense to the state.

24 EXPLANATION

25 This bill legalizes the proceedings of the United Community
 26 School District in issuing school building bonds in 1971.
