## A BILL FOR

1 An Act relating to the possession and consumption of alcoholic  
2 liquors and beer on school grounds.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 Section 1. Chapter one hundred thirty-one (131), section  
5 forty-six (46), Acts of the Sixty-fourth General Assembly,  
6 First Session, is amended to read as follows:

7 Sec. 46. CONSUMPTION IN PUBLIC PLACES--INTOXICATION. It  
8 is unlawful for any person to use or consume alcoholic liquors  
9 or beer upon the public streets or highways, or alcoholic  
10 liquors in any public place, except premises covered by a  
11 liquor control license, or to possess or consume alcoholic  
12 liquors or beer on any public or private school property or  
13 while attending any public or private school related functions,  
14 and no person shall be intoxicated nor simulate intoxication in  
15 a public place. Any person violating any provisions of this  
16 section shall be fined not to exceed one hundred dollars or  
17 sentenced not to exceed thirty days in the county jail.

### EXPLANATION

19 This bill prohibits possession and consumption of alcoholic  
20 liquors or beer on any public or private school property.
