## A BILL FOR

1 An Act making an appropriation to the office of secretary  
2 of state to defray expenses relating to the administra-  
3 tion of election laws.  
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:  
5 Section 1. There is appropriated from the general fund  
6 of the state to the office of secretary of state for the fis-  
7 cal year beginning July 1, 1972 and ending June 30, 1973,  
8 the sum of twenty-five thousand (25,000) dollars, or so much  
9 thereof as may be necessary, for the purpose of paying the  
10 expenses of administering the division of elections created  
11 pursuant to House File 1147 as approved and enacted by the  
12 Sixty-fourth General Assembly, Second Session. The funds  
13 appropriated by this Act may be expended for paying the salary  
14 of a person appointed to be in charge of the division of elec-  
15 tions and any other necessary salaries and expenses incurred  
16 in administering a division of elections. The funds appro-  
17 priated by this Act shall be in addition to any other funds  
18 appropriated by the general assembly for use of the secretary  
19 of state in administering his office and carrying out his  
20 duties in relation to the administration of election laws  
21 and procedures, and this Act shall not be construed as  
22 prohibiting the use for such purpose of any funds appropriated  
23 to the office of secretary of state.

### EXPLANATION

24  
25 This bill provides additional funds for the office of

1 secretary of state to carry out additional duties in regard  
2 to the administration of election laws which have been im-  
3 posed by legislation proposed or enacted by the Second Ses-  
4 sion of the Sixty-fourth General Assembly.

1 Amend House File 1213 as follows:

2 1. Page 1, by striking all of lines 7 and 8 and  
3 inserting in lieu thereof the following: "cal year  
4 beginning July 1, 1971 and ending June 30, 1972, the  
5 sum of eight thousand (8,000) dollars, and for the  
6 fiscal year beginning July 1, 1972 and ending June  
7 30, 1973, the sum of seventeen thousand (17,000)  
8 dollars, or so much".

9 2. Page 1, by inserting after line 23 the  
10 following new section:

11 "Sec. 2. This Act, being deemed of immediate  
12 importance, shall take effect and be in force from  
13 and after its publication in the DeWitt Observer,  
14 a newspaper published in DeWitt, Iowa, and in The  
15 Guttenburg Press, a newspaper published in  
16 Guttenburg, Iowa.

25 6 new paragraph:

26 7 The county commissioner of elections shall  
27 8 receive a salary equal to ten percent of the salary  
28 9 of the county auditor, in addition to his salary  
10 as county auditor."

11 2. Amend the title, line 3, by adding after the word  
12 "laws" the words "and providing a salary for the county  
13 commissioner of elections".
