A BILL FOR

1 An Act relating to the establishment of rest areas or rest
2 area buildings on interstate highways.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 Section 1. Section three hundred thirteen point two (313.2),
5 unnumbered paragraph four (4), Code 1971, is amended as follows:

6 The state highway commission, either alone or in co-
7 operation with any county, shall have the authority to utilize
8 any land acquired incidental to the acquisition of land for
9 highway right of way and to also accept by gift, lands not
10 exceeding two acres in area for roadside parks and parking
11 areas. The commission may furnish necessary maintenance. The
12 commission shall also have authority to accept by gift, equip-
13 ment or other installations incidental to the use of said
14 parks and parking areas. Said parks and parking areas shall
15 be a part of the primary road system and the commission may
16 at its discretion sell or otherwise dispose of said lands.
17 No rest areas or rest area buildings shall be established or
18 constructed on an interstate highway at intervals of less than
19 sixty miles; except, the state highway commission is directed
20 to establish and construct a rest area and rest area buildings
21 on interstate highway twenty-nine in Mills county south of
22 its intersection with primary road three hundred seventy and a
23 rest area and rest area buildings on interstate highway
24 eighty north in Pottawattamie county near Loveland.

EXPLANATION

2 This bill will permit the state highway commission to
3 complete the development and the construction of rest areas
4 in Mills and Pottawattamie counties which are located closer
5 than 60 miles apart.
