## A BILL FOR

1 An Act to change certain references in the Code from "poultry  
2 and hatchery association" to "poultry association, incor-  
3 porated".

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

5 Section 1. Section one hundred fifty-nine point twenty-  
6 five (159.25), Code 1971, is amended as follows:

7 159.25 MARKETING BOARD. There is hereby established an  
8 agriculture marketing board, to be thus known and designated.

9 The agriculture marketing board shall be composed of the  
10 secretary of agriculture and the dean of agriculture at Iowa  
11 State University of science and technology who shall serve as  
12 members of the advisory board without vote, and a producer  
13 member from each of the following statutory associations: Iowa  
14 swine producers association, Iowa beef cattle producers associa-  
15 tion, Iowa state sheep association, Iowa poultry and-hatchery  
16 association, incorporated, Iowa state dairy association, Iowa  
17 crop improvement association, Iowa soybean association, Iowa  
18 corn growers association, and state horticulture society. The  
19 names of three persons shall be certified to the secretary of  
20 agriculture by the presidents of the Iowa swine producers associa-  
21 tion, Iowa beef cattle producers association, Iowa poultry and  
22 hatchery association, incorporated, and state horticulture society  
23 by June 1 of each odd numbered-year. The secretary of agricul-  
24 ture shall appoint by July 1 one of these three from each organ-  
25 ization to the agriculture marketing board. Such an appointee

1 shall serve for a period of two years beginning on July 1 of  
2 the year of his appointment and until his successor is appointed  
3 or qualified. Three names shall be submitted and appointments  
4 made in the same manner in even-numbered years for representation  
5 from the Iowa state dairy association, Iowa soybean association,  
6 Iowa corn growers association, Iowa state sheep association,  
7 and Iowa crop improvement association. Any vacancy occurring  
8 in the agriculture marketing board shall be filled within two  
9 months of the vacancy in the manner provided in this section.

10 Appointive members of the board shall receive actual necessary  
11 expenses and mileage at the rate of seven cents per mile incurred  
12 while engaged in the business of the agriculture marketing board.

13 EXPLANATION

14 This bill updates references to the Iowa Poultry Association,  
15 Incorporated, which appear in the list of groups represented on  
16 the agriculture marketing board.
