A BILL FOR

1 An Act to legalize and validate the proceedings of the City
2 Council of the City of Windsor Heights and the City Council
3 of the City of Clive, in the County of Polk, State of Iowa,
4 in adopting an Intergovernmental Corporation Boundary
5 Agreement and establishing a portion of their common corpor-
6 ation boundary line and in taking action in reliance thereon.

7 WHEREAS, the City of Clive and the City of Windsor Heights,
8 in the County of Polk, State of Iowa, by their respective City
9 Councils, did heretofore enter into a certain intergovernmental
10 agreement pursuant to Chapter 28E, Code of Iowa, 1971, entitled
11 Intergovernmental Corporation Boundary Agreement and dated the
12 18th day of March, 1971, the said Agreement having been approved
13 by the City Council of The City of Windsor Heights, Iowa, on
14 March 15, 1971, and by the City Council of the City of Clive,
15 Iowa, on March 18, 1971; and

16 WHEREAS, said agreement serves to finally fix and determine
17 a portion of the common corporation boundary line of said Cities
18 and to eliminate uncertainties and conflicts in official records
19 with respect to said boundary; and

20 WHEREAS, it is deemed advisable to put to rest such doubts
21 as have arisen with respect to the validity and legal suffi-
22 ciency of said agreement and action taken by said Cities in
23 reliance upon said agreement; NOW, THEREFORE:

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

25 Section 1. All proceedings heretofore taken by the City

1 Councils of the City of Windsor Heights and the City of Clive,
2 in the County of Polk, State of Iowa, in connection with the
3 execution, approval and adoption of the Intergovernmental
4 Corporation Boundary Agreement dated March 18, 1971, and the
5 common corporation boundary line fixed and established by said
6 agreement are hereby legalized, validated and confirmed, and
7 all actions taken by said Cities in reliance upon or in recog-
8 nition of said agreement or the common corporation boundary
9 line therein established are hereby declared to be lawful and
10 proper insofar as the same may relate to the boundary line so
11 established.

12 Section 2. This act, being deemed of immediate importance,
13 shall be in full force and effect from and after its passage,
14 approval and publication in the West Des Moines Express, a
15 newspaper published at West Des Moines, Iowa, and the Des Moines
16 Register, a newspaper published at Des Moines, Iowa, without
17 expense to the State.

18 EXPLANATION

19 The specific boundary line between the cities of Clive and
20 Windsor Heights has been in doubt for some time. The two
21 cities have now executed an agreement as to the exact boundary
22 lines, which is essential for many legal reasons, and the pur-
23 pose of this Act is to legalize the agreement and the boundary
24 lines established pursuant to the agreement.
