14 Sec. 2. Notwithstanding the provisions of section eight  
15 point thirty-three (8.33) of the Code, all unencumbered or  
16 unobligated balances of appropriations made by this Act for  
17 the first fiscal year of the biennium commencing July 1, 1971  
18 shall, on September 30, 1972, revert to the state treasury  
19 and to the credit of the fund from which appropriated. In  
20 all other respects the provisions of section eight point  
21 thirty-three (8.33) of the Code shall apply to appropriations  
22 made for the first fiscal year of such biennium. Unencumbered  
23 or unobligated balances of appropriations made for the second  
24 fiscal year of such biennium shall be subject to section eight  
25 point thirty-three (8.33) of the Code.
