5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

2 employees' retirement system fund for each fiscal year of  
3 the biennium beginning July 1, 1971 and ending June 30, 1973  
4 for the employment security commission, the following amounts,  
5 or so much thereof as may be necessary, to be used for the  
6 following purposes:

14 Sec. 2. Notwithstanding the provisions of section eight  
15 point thirty-three (8.33) of the Code, all unencumbered or  
16 unobligated balances of appropriations made by this Act for  
17 the first fiscal year of the biennium commencing July 1, 1971  
18 shall, on September 30, 1972, revert to the state treasury  
19 and to the credit of the fund from which appropriated. In  
20 all other respects the provisions of section eight point  
21 thirty-three (8.33) of the Code shall apply to appropria-  
22 tions made for the first fiscal year of such biennium. Un-  
23 encumbered or unobligated balances of appropriations made  
24 for the second fiscal year of such biennium shall be sub-  
25 ject to section eight point thirty-three (8.33) of the Code.
