1 Section 1. For the designated commissions, boards and
 2 departments, there is hereby appropriated all funds received
 3 under authority of the designated chapters or sections of
 4 the Code for the biennium beginning July 1, 1971 and ending
 5 June 30, 1973. The following amounts, or so much thereof
 6 as may be necessary, are authorized to be expended from said
 7 receipts to be used for the following purposes, to wit:

22 Sec. 2. Notwithstanding the provisions of section eight
23 point thirty-three (8.33) of the Code, all unencumbered or
24 unobligated balances of appropriations made by this Act for
25 the first fiscal year of the biennium commencing July 1, 1971
26 shall, on September 30, 1972, revert to the state treasury
27 and to the credit of the fund from which appropriated. In
28 all other respects the provisions of section eight point
29 thirty-three (8.33) of the Code shall apply to appropriations
30 made for the first fiscal year of such biennium. Unencumbered
31 or unobligated balances of appropriations made for the second
32 fiscal year of such biennium shall be subject to section eight
33 point thirty-three (8.33) of the Code.

34 Sec. 3. Where any laws of this state are in conflict with
35 this Act, the provisions of this Act shall govern for the *biennium*.

1 Amend House File 700 as follows:
2 1. Page 2, line 4, by striking the word "biennium"
3 and inserting in lieu thereof the words "fiscal year".
4 2. Page 2, line 5, by striking the numeral "1973"
5 and inserting in lieu thereof the numeral "1972".
6 3. Page 2, lines 8 and 9, by striking the following:
7 "1972-73
8 Fiscal Year"
9 and by striking the numerals under that column on pages
10 2 and 3.
