1 Section 1. There is appropriated from the general fund
 2 of the state for each fiscal year of the biennium commenc-
 3 ing July 1, 1971 and ending June 30, 1973 for the Iowa
 4 reciprocity board, the following amounts, or so much thereof
 5 as may be necessary, to be used for the following purposes,
 6 to wit:

18 The state comptroller
 19 shall at the earliest pos-
 20 sible date employ a person
 21 or persons or direct someone
 22 employed by him to carry out
 23 the provisions of this subsec-
 24 tion. The person or persons
 25 employed or directed to carry
 26 out the provisions of this Act
 27 shall serve at the pleasure of
 28 the state comptroller and shall
 29 be paid from funds appropriated
 30 to the office of the state comp-
 31 troller. The Iowa reciprocity
 32 board shall reimburse the office
 33 of the state comptroller for the
 34 payment of such funds from the

1 funds appropriated by this Act.

2 3. Grand total of all ap-
3 propriations for all purposes
4 for each fiscal year of the
5 biennium for the Iowa reciproc-
6 ity board. \$207,630.00. \$164,340.00

7 Sec. 2. Notwithstanding the provisions of section eight
8 point thirty-three (8.33) of the Code, all unencumbered or
9 unobligated balances of appropriations made by this Act for
10 the first fiscal year of the biennium commencing July 1, 1971
11 shall, on September 30, 1972, revert to the state treasury
12 and to the credit of the fund from which appropriated. In
13 all other respects the provisions of section eight point
14 thirty-three (8.33) of the Code shall apply to appropriations
15 made for the first fiscal year of such biennium. Unencumbered
16 or unobligated balances of appropriations made for the second
17 fiscal year of such biennium shall be subject to section eight
18 point thirty-three (8.33) of the Code.

19 Sec. 3. Where any laws of this state are in conflict with
20 this Act, the provisions of this Act shall govern for the
21 biennium.
