23 Sec. 2. All federal grants to and the federal receipts

24 of the state department of health and its divisions, includ-

25 ing the Iowa water pollution control commission and the Iowa

26 air pollution control commission, are appropriated for the

27 purpose set forth in the federal grants or receipts.

28 Sec. 3. When any provisions of the laws of this state

29 are in conflict with this Act in designating certain fund

30 accounts to be used for certain purposes, the provisions of

31 this Act shall govern for the biennium.

32 Sec. 4. No funds appropriated by this Act shall be used

33 for capital improvements.

34 Sec. 5. Notwithstanding the provisions of section eight

35 point thirty-three (8.33) of the Code, all unencumbered or

1 unobligated balances of appropriations made by this Act for  
 2 the first fiscal year of the biennium commencing July 1, 1971  
 3 shall, on September 30, 1972, revert to the state treasury  
 4 and to the credit of the fund from which appropriated. The  
 5 state department of health may make application to the appro-  
 6 priation committees for the reappropriation of any funds that  
 7 do revert, or probably will revert upon the dates herein set  
 8 and the respective appropriation committees or a subcommittee  
 9 thereof shall hold a hearing upon such application while the  
 10 general assembly is in regular session. In all other respects  
 11 the provisions of section eight point thirty-three (8.33)  
 12 of the Code shall apply to appropriations made for the first  
 13 fiscal year of such biennium. Unencumbered or unobligated  
 14 balances of appropriations made for the second fiscal year  
 15 of such biennium shall be subject to section eight point  
 16 thirty-three (8.33) of the Code.
