1 Section 1. There is appropriated from funds in the gen-
2 eral fund of the state, not otherwise appropriated, to merged
3 area I, the sum of two hundred thousand (200,000) dollars
4 for the purpose of operating the attendance center which
5 merged area I is required to operate by the provisions of
6 section two hundred eighty A point forty (280A.40) of the
7 Code.

8 The appropriation provided by this Act shall be paid by
9 the state comptroller to the treasurer of merged area I as
10 follows:

11 For the year beginning July 1, 1971 \$100,000.00
12 For the year beginning July 1, 1972 \$100,000.00

13 Sec. 2. Notwithstanding the provisions of section eight
14 point thirty-three (8.33) of the Code, all unencumbered or
15 unobligated balances of appropriations made by this Act for
16 the first fiscal year of the biennium commencing July 1, 1971
17 shall, on September 30, 1972, revert to the state treasury
18 and to the credit of the fund from which appropriated. Merged
19 area I may make application to the committees on appropria-
20 tions for the reappropriation of any funds that do revert,
21 or probably will revert upon the dates herein set and the
22 respective committees on appropriations or a subcommittee
23 thereof shall hold a hearing upon the application while the
24 general assembly is in regular session. In all other respects
25 the provisions of section eight point thirty-three (8.33)
26 of the Code shall apply to appropriations made for the first
27 fiscal year of such biennium. Unencumbered or unobligated
28 balances of appropriations made for the second fiscal year
29 of such biennium shall be subject to section eight point
30 thirty-three (8.33) of the Code.

31 EXPLANATION

32 The purpose of this bill is to provide operating funds
33 for the additional attendance center which the 63rd General
34 Assembly required Merged Area I to operate when it enacted
35 section 280A.40, Code 1971.
