1 Section 1. Section two hundred seventeen point three (217.3),  
2 Code 1971, is amended by adding the following new subsection:

3 9. Have prepared and currently maintained a list of all  
4 persons in this state who are deaf, blind, or severely handi-  
5 capped.

6 Sec. 2. Section two hundred ninety-nine point seventeen  
7 (299.17), Code 1971, is repealed.

8 EXPLANATION

9 This bill takes the responsibility of making a state list  
10 of all deaf, blind, or severely handicapped persons away from  
11 the county assessors and gives it to the department of social  
12 services.
