1 Section 1. The commissioner of social services may,
2 subject to the approval of the executive council, grant
3 easements to the municipal corporation of Eldora, Iowa,
4 in order that water and sewage lines to the Eldora training
5 school for boys may be installed and maintained.

6 Sec. 2. This shall be printed in the session laws only
7 and shall not be printed as a permanent section of the
8 Code of Iowa.

9 EXPLANATION

10 This bill allows the commissioner of social services,
11 subject to the approval of the executive council, to grant
12 the city of Eldora water and sewage easements so that the
13 city may provide water and sewage service to the Eldora
14 Training School for Boys.

1 Amend Senate File 1046 as follows:

2 1. Page 2 after line 5 by adding the following new sections:
3 "Sec. _____. The commissioner of social services may, subject
4 to the approval of the Executive Council, grant sewage easement
5 rights to the municipal corporation of the city of Marshalltown,
6 Iowa, for the installation of sanitary sewer line in and over a
7 portion of the Iowa Soldiers Home grounds at Marshalltown, Iowa,
8 for the purpose of installing, repairing, maintaining, and
9 improving sanitary sewer service to portions of said city and
10 the Iowa Soldiers Home.

11 Sec. _____. This Act, being deemed of immediate importance,
12 shall take effect and be in force from and after its publication
13 in the Eldora Herald-Ledger, a newspaper published in Eldora,
14 Iowa, and in the Marshalltown Times-Republican, a newspaper
15 published in Marshalltown, Iowa."

16 2. Renumber the following section accordingly.

17 3. Page 1, line 2 by striking all after the word "sewage" and
18 all of line 3 and by inserting in lieu thereof the following:
19 "easements to the municipal corporations of Eldora and
20 Marshalltown."

EXPLANATION OF AMENDMENT

1 The grant of easement to the city of Marshalltown for
2 sewage easement rights over a portion of the Iowa Soldiers
3 Home grounds is for the installation of a new sewer through
4 the Iowa Soldiers Home property. The city of Marshalltown
5 has an established sanitary sewer system with an existing
6 main trunk line now located on a portion of said grounds
7 serving the Iowa Soldiers Home and other parts of said city
8 which is in need of repair and replacement with a larger
9 sewer line.
