 5 structing off-street parking facilities in accordance with
 6 Chapter 390 of the 1966 Code of Iowa.

1 WHEREAS, on the 24th day of June 1968, the City Council
2 of the City of Red Oak, Montgomery County, Iowa, voted to
3 purchase the following described real estate for off street
4 parking purposes for the sum of \$14,500.00 pursuant to
5 authority granted by Chapter 390 of the 1966 Code of Iowa:
6 Lot No 6 (6) and the West Half of Lot No 5 (W 1/2 of Lot
7 5) in Block No Twenty-Eight (28) in the City of Red Oak, Iowa,
8 and

9 WHEREAS, doubts have arisen concerning the validity of
10 said proceedings and their legal sufficiency due to a failure
11 to conduct a public hearing in accordance with Chapter 390.1
12 of the 1966 Code of Iowa, prior to the Council approving said
13 purchase and

14 WHEREAS, it is deemed advisable to put such doubts and
15 all others that might arise concerning the same forever at
16 rest, now THEREFORE,

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

18 Section 1.

19 That all proceedings heretofore taken by the City Council
20 of the City of Red Oak, in the County of Montgomery, Iowa,
21 preliminary to and in connection with the purchase of real
22 property for the construction of off street parking facilities
23 pursuant to the authority granted in Chapter 390 of the 1966
24 Code of Iowa, and which real estate is described as follows:

25 Lot No six (6) and the West Half of Lot No Five (W 1/2
26 of Lot 5) in Block Twenty-eight (28) of the City of Red Oak,
27 Montgomery County, Iowa,

28 are hereby legalized and confirmed and that the purchase
29 of the above described real property for the construction
30 of off street parking facilities is hereby declared to be
31 legal and the title to the same confirmed in the City of Red
32 Oak, and the payment for said building in the sum of \$14,500.00
33 and acceptance of title thereto is declared to be a legal
34 and binding act of the City Council of the said City of Red
35 Oak.
