A BILL FOR

1 An Act to provide that expenditures of funds by the county
2 board of supervisors to replace property acquired by another
3 governmental body need not be submitted to the voters.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

5 Section 1. Section three hundred forty-five point one
6 (345.1), Code 1971, is amended as follows:

7 345.1 EXPENDITURES--WHEN VOTE NECESSARY. The board of
8 supervisors shall not order the erection of, or the building
9 of an addition or extension to, or the remodeling or reconstruc-
10 tion of a courthouse, jail, county hospital,* or county home
11 when the probable cost will exceed ten thousand dollars, or any
12 other building, except as otherwise provided, when the probable
13 cost will exceed ten thousand dollars, nor the purchase of
14 real estate for county purposes exceeding ten thousand dollars
15 in value, until a proposition therefor shall have been first
16 submitted to the legal voters of the county, and voted for by
17 a majority of all persons voting for and against such proposition
18 at a general or special election, notice of the same being
19 given as in other special elections. ~~Except, however~~ However,
20 such proposition need not be submitted to the voters if any
21 such erection, construction, remodeling, reconstruction, or
22 purchase of real estate may be accomplished without the levy
23 of additional taxes and the probable cost will not exceed fifty
24 thousand dollars or when a relocation is made necessary by
25 the acquisition of county property for a federal or state

1 project, and the cost of the relocation does not exceed the
2 amount of the award of damages by the state or federal govern-
3 ment.

4 EXPLANATION

5 This bill provides that a county board of supervisors need
6 not submit a proposition to the voters to relocate property
7 when the relocation was made necessary by state and federal
8 governments taking of their property, and the cost does not
9 exceed the federal or state award.
