A BILL FOR

1 An Act relating to student fees at merged area community
2 colleges and vocational schools.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 Section 1. Section two hundred eighty A point eighteen
5 (280A.18), Code 1971, is amended by adding the following new
6 subsection:

7 "Student fees may be collected from students for activities,
8 laboratory breakage, instructional materials, and other objects
9 and purposes for which student fees other than tuition are
10 customarily charged by colleges and universities, as provided
11 in a schedule of fees adopted by the area board of directors.
12 The expenditure of funds collected from students for activities
13 shall be determined by the student government unit with admin-
14 istrative and board approval.

15 After June 30, 1971, any increases in student fees for
16 activities shall be determined by the student government unit
17 with administrative and board approval."

18 EXPLANATION

19 The purpose of this bill is to expressly state the authority
20 of merged areas, to adopt, collect, and expend student fees.
