A BILL FOR

1 An Act to provide an appropriation from the general fund of
2 the state for capital improvements for the Iowa law en-
3 forcement academy.

1 Section 1. There is appropriated from the general fund
2 of the state, subject to the provisions of section two (2)
3 of this Act, for the biennium beginning July 1, 1971 and end-
4 ing June 30, 1973 to the Iowa law enforcement academy the
5 sum of fifty thousand (50,000) dollars, or so much thereof
6 as may be necessary, to be used for constructing or obtaining
7 dormitory, classroom and dietary facilities.

8 Sec. 2. The Iowa law enforcement academy, the governor
9 and the state comptroller shall make application for federal
10 grants to the state to be used in connection with the funds
11 to be appropriated by this Act. The funds appropriated by
12 this Act shall not be expended until federal grants or federal
13 matching funds in an amount equal to or greater than the
14 amount of funds available under the provisions of this Act
15 are received by the state.

16 Sec. 3. Plans and specifications for improvements for
17 which funds are appropriated by this Act shall be submitted
18 to the budget and financial control committee for approval,
19 except that items commonly known as change orders need not
20 be submitted to the budget and financial control committee
21 unless such change orders actually increase the total cost
22 of the project.

23 Sec. 4. Any unencumbered balance remaining as of June
24 30, 1973 of the appropriation to be provided for by this Act,
25 shall revert to the general fund of the state as of June 30,
26 1973.
