A BILL FOR

1 An Act to establish the salary rate for the superintendent
 2 of the department of public instruction.
 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:
 4 Section 1. The salary of the superintendent of public
 5 instruction for each year of the fiscal biennium commencing
 6 July 1, 1971 and ending June 30, 1973 shall be paid from funds
 7 appropriated to the department of public instruction and shall
 8 be at the rate of twenty-five thousand (25,000) dollars for
 9 the 1971-72 fiscal year, and twenty-five thousand (25,000)
 10 dollars for the 1972-73 fiscal year.

EXPLANATION

 12 This bill sets the salary rate to be paid to the
 13 superintendent of public instruction. Funds for payment of
 14 the salary will be contained in the appropriation bill for
 15 the department of public instruction.

8 law for the superintendent of public instruction.
9 However, the provisions of this section shall not apply
10 to employment contracts executed pursuant to section
11 two hundred seventy-nine point fourteen (279.14) of
12 the Code prior to the effective date of this Act."
13 2. Amend the title, line 2, by inserting after the
14 word "instruction" the words "and to limit the salaries
15 of superintendents of schools of school districts and
16 county superintendents of schools".
