10 Sec. 2. It is the intent of the general assembly in mak-  
11 ing this supplemental appropriation that all liquor stores  
12 open on the effective date of this Act shall remain open and  
13 eight new stores budgeted for in the budget for the 1973-75  
14 fiscal biennium will be opened.

15 Sec. 3. This Act, being deemed of immediate importance,  
16 shall take effect and be in force from and after its publica-  
17 tion in the Clinton Herald, a newspaper published in Clinton,  
18 Iowa, and in The Woodbine Twiner, a newspaper published in  
19 Woodbine, Iowa.
