A BILL FOR

1 An Act relating to reversions of appropriations made for
2 state libraries and providing a supplemental appropriation.
3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Acts of the Sixty-fifth General Assembly, 1973
2 Session, chapter thirteen (13), is amended by adding the fol-
3 lowing section:

4 Sec. 5. 1. From funds appropriated by subsection three
5 (3) of section one (1) of this Act for the fiscal year be-
6 ginning July 1, 1973 and ending June 30, 1974 there shall
7 be reverted to the general fund of the state the sum of two
8 hundred eighty-one thousand three hundred thirty-four (281,334)
9 dollars.

10 2. If federal funds are received by the state library
11 commission to be used for the purposes for which funds were
12 appropriated pursuant to subsection three (3) of section one
13 (1) of this Act for the fiscal year beginning July 1, 1974
14 and ending June 30, 1975, funds in the amount of two hundred
15 eighty-six thousand five hundred seven (286,507) dollars
16 which were appropriated by subsection three (3) of section
17 one (1) of this Act shall revert to the general fund of the
18 state following the receipt of such federal funds.

19 Sec. 2. Acts of the Sixty-fifth General Assembly, 1973
20 Session, chapter thirteen (13), is amended by adding the fol-
21 lowing section:

22 Sec. 7. STATEMENT OF INTENT. It is the intent of the
23 general assembly that funds appropriated pursuant to subsec-
24 tion three (3) of section one (1) of this Act for the fiscal
25 year beginning July 1, 1973 shall be reduced by two hundred
26 eighty-one thousand three hundred thirty-four (281,334) dol-
27 lars, which amount represents federal funds received for such
28 fiscal year. It is also the intent of the general assembly
29 that funds appropriated for the fiscal year beginning July 1,
30 1974 pursuant to subsection three (3) of section one (1) of
31 this Act shall be reduced by two hundred eighty-six thousand
32 five hundred seven (286,507) dollars, if federal funds be-
33 come available to carry out the purposes for which funds
34 were appropriated pursuant to subsection three (3) of sec-
35 tion one (1) of this Act.

1 Sec. 3. 1. There is appropriated from the general fund
2 of the state to the state library commission for the fiscal
3 year beginning July 1, 1974 and ending June 30, 1975, the
4 sum of twenty-five thousand (25,000) dollars, or so much
5 thereof as may be necessary, to be used for purposes set
6 out in section eleven (11), subsection four (4), chapter
7 two hundred (200), Acts of the Sixty-fifth General Assembly,
8 1973 Session.

9 2. Any unencumbered balance of funds appropriated by sub-
10 section one (1) of this section remaining on June 30, 1975,
11 shall revert to the general fund of the state on September
12 30, 1975.

13 Sec. 4. This Act, being deemed of immediate importance,
14 shall take effect and be in force from and after its publica-
15 tion in the Iowa City Press-Citizen, a newspaper published
16 in Iowa City, Iowa, and in The Denison Bulletin, a newspaper
17 published in Denison, Iowa.
