1 Section 1. There is appropriated from the general fund
2 of the state to the following named persons the amounts set
3 opposite their names in full settlement of all per diem and
4 expense claims they may have against the state for services
5 rendered the house ethics committee through March 11, 1974:

- 6 Don W. Burlington..... \$224.45
- 7 Howard M. Remley..... \$289.27

8 Sec. 2. The state comptroller may issue warrants to the
9 persons named in this Act in the amounts stated, and the
10 treasurer of state shall pay the same from the general fund
11 of the state.

12 Sec. 3. The acceptance of the sums by the persons named
13 in this Act shall be in full settlement of all claims against
14 the state of Iowa growing out of the claims described.

4 Section 1. Section sixty-eight B point ten
5 (68B.10), unnumbered paragraph one (1), Code 1973, is
6 amended to read as follows:

7 There shall be an ethics committee in the senate
8 and an ethics committee in the house, each to consist
9 of seven members; three members to be appointed by the
10 majority leader in each house, two members by the minority
11 leader in each house and two individuals who shall not
12 be employees of the general assembly by the chief jus-
13 tice of the Iowa supreme court. The two individuals
14 appointed by the chief justice of the supreme court
15 shall receive a per diem of forty dollars and travel
16 expenses at the same rate as paid members of interim
17 committees for attending meetings of the ethics commit-
18 tee. Members of the general assembly shall receive a
19 per diem of forty dollars and travel expenses at the
20 same rate as paid members of interim committees for
21 attending meetings held when the general assembly is
22 not in session. The per diem and expenses shall be
23 paid from funds appropriated by section two point
24 twelve (2.12) of the Code.
