1 An Act relating to the per diem rate of specified boards and
2 a committee.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section one hundred seventy-three point eight
2 (173.8), Code 1973, is amended by striking the section and
3 inserting in lieu thereof the following:

4 173.8 COMPENSATION AND EXPENSES. A member of the board
5 elected at the annual convention shall be paid a forty dollar
6 per diem and shall be reimbursed for actual and necessary ex-
7 penses incurred while engaged in official duties. All per
8 diem and expense moneys paid to a member shall be paid from
9 funds of the state fair board.

10 Sec. 2. Acts of the Sixty-fourth General Assembly, 1972
11 Session, chapter one thousand eighty-eight (1088), section
12 ninety-five (95), unnumbered paragraph two (2), is amended
13 to read as follows:

14 Each member is entitled to receive his actual and neces-
15 sary expenses incurred in the performance of committee duties.
16 Each member other than the state official members is also
17 entitled to receive ~~thirty~~ forty dollars compensation for
18 each day spent in performance of committee duties.

19 Sec. 3. Acts of the Sixty-fourth General Assembly, 1972
20 Session, chapter one thousand eighty-eight (1088), section
21 thirty-three (33), unnumbered paragraph two (2), is amended
22 to read as follows:

23 Each member is entitled to receive from the state his actual
24 and necessary expenses and ~~thirty~~ forty dollars compensation
25 for each day spent in performance of board duties.

26 EXPLANATION

27 This bill raises the per diem rate for the state fair
28 board, city finance committee, and city development board
29 from thirty to forty dollars.

1 Amend House File 1478 as follows:

2 1. Page 2, by inserting after line 25 the follow-
3 ing:

4 Sec. _____. Section four hundred fifty-five B point
5 six (455B.6), Code 1973, is amended to read as follows:
6 455B.6 EXECUTIVE COMMITTEE. The executive com-
7 mittee of the department shall consist of the chairmen
8 of the four commissions within the department. When
9 members of the executive committee are unable to
10 attend a meeting, they shall designate a member of
11 their respective commission to serve in their place.
12 The director of the state conservation commission,
13 the administrative officer of the department of soil
14 conservation, the director of the bacteriological
15 laboratory at the state university of Iowa, the sec-
16 retary of agriculture, the commissioner of public
17 health, and the state geologist, or their designees
18 shall be ex officio, nonvoting members of the execu-
19 tive committee. The executive committee shall organize
20 annually during the month of July and select a chair-
21 man and vice-chairman. The executive director shall
22 act as the secretary of the executive committee.
23 Meetings shall be called by the chairman or upon
24 written request of any two voting members. A majority
25 of the executive committee shall constitute a quorum
26 and the concurrence of a majority of the executive
27 committee shall be required to determine any matter
28 relating to its duties. The voting members of the
29 executive committee shall be paid a forty dollar per
30 diem of-thirty-dollars-per-day while in session, ten
31 cents-a-mile-for-travel, and shall be reimbursed for
32 their reasonable actual and necessary expenses while
33 attending-such-meetings engaged in the performance of
34 of their official duties as members of the executive
35 committee. All per diem and expense moneys paid to
36 members shall be paid from funds appropriated to the
37 commission of which they are members.

38 2. Amend the title on page 1, lines 1 and 2, by
39 striking the words "of specified boards and a commit-
40 tee" and inserting in lieu thereof the words ", ex-
41 penses and duties of specified boards and committees".

42 3. By numbering the section to conform to this
43 amendment.
